Meeting called to order

Introduction of Members

Review of minutes from the April 2023 Meeting

- Motion to accept the minutes as written: Levi Dominguez
- Second: Mark Francisco
- · Vote: all aye, none opposed

Training Report

- Failure of the Initial PT Assessment continues to be biggest cause of dismissal from training
- Craig Smith asks if WLEA still invites alternates, to fill the spots of those who fail on the first day
 - There have not been enough students registered for a class to require this since
- Levi Dominguez asks if WLEA has considered allowing "conditionals" again

- The standard is the standard even if a student fails by 1 pushup, that is where the line is drawn
- Unlike several years ago, the physical skills training starts on day 2 of the Basic, so there is no additional time to prepare like there used to be
- Several years ago, WLEA did one-year moratorium with no initial PT standard for DOB
 - o Test scores were lower, there were more injuries, and more behavioral issues
- WLEA's standard is lower than other states
 - For example, Georgia requires students to score a 75%
- Chris Walsh would strongly advise the POST Commission not to lower the PT standard
- WLEA has a fitness training program available online
 - Post-meeting note: this program is available here: https://www.wleacademy.com/fitness-standards
- The Board discussed the possibility of students who fail the Initial PT Assessment retaking it the next morning
 - Students would need to complete the entire assessment again, not only the section(s) they failed

Updated DOB Curriculum

- Updates were made based on the result of the Job Task Analysis and consultation with the Detention Training Advisory Board
- 7 hours were removed
- 19 hours were added
- 5 existing topics were amended
- The total course hours increased from 298 to 310

Peace Officer Basic Job Task Analysis

- The JTA is being completed by Val Lubans, who has worked with WLEA before
- The technical committee met with Val and determined the task list
- Survey respondents from agencies across the state have been identified
- WLEA is not anticipating changes to POB in 2024, as the JTA won't be completed until part way through the year

Communications Basic Report

- The class is now 83 hours up from 55 hours previously
- WLEA received positive feedback from the students that participated in the first running of the new curriculum back in March
- WLEA requests feedback on advanced training classes that dispatchers would like to attend

Advanced Training Report

- There have been more training courses this year than last year
- There does seem to be a lack of interest in Custody & Control courses
- Per Ronnie Jones, DCI has a training available regarding human trafficking

- This training is specifically geared towards patrol officers
- DCI is open to WLEA hosting this training

OET Funding Report

 The Officer Education and Training Fund has covered the cost of 38 courses over the last biennium

Bike Test

- WLEA has noticed an increase in bike tests for the Initial PT Assessment
- Data shows that students who do the bike have a higher failure rate than those who run
- The full details are available in the packet provided to the Board Members

Final PT Assessment

- WLEA has noticed an increase in the number of failures on the Final PT Assessment
- In the last DOB, several students scored 0%
- Should the Final PT Assessment count in some way?
- Many other academies do have an exit PT requirement
- WLEA is considering the possibility of moving to a physical skills test of job related tasks

Dual Cert Concerns

- The Dual Certification Course was initially intended for veteran officers, not officers who just came through Peace Officer Basic
- Many agencies are sending new officers to POB, and then enrolling them in Dual Cert as soon as they graduate
- Per POST, the basic training standards **are** being met, even in these cases
- Overuse of the Dual Certification Course could result in fewer Detention Officer Basics per year

Cost Increases

- A new bid will go out soon for ammunition, as the current ammo provider has become unable to fulfill orders
- Ammo costs are surely going to increase
- Food costs are projected to go up 12-27% in 2024

Facility Presentation

- Facility Manager Brian Brooks presented updates being made to the WLEA campus
 - Planned updates include renovated dormitory rooms, new firearms ranges, and a new EVO driving course
