### **CRI-TAC Final Report**

- COPS office determined that anything developed or presented in this course of this project would become public property, which hampered the efforts of the project.
- The final "deliverable" was not what was anticipated and discussed at the beginning of this process.
- The full deliverable is available for review in the packet provided to the Board.

## **Detention JTA Update**

- Currently 60% of the way through the process
- So far, 87% response rate to the survey
- Val Lubans will be at WLEA in December to meet with the technical committee again.
- Lubans' final report will be available at the end of January.

 WLEA anticipates presenting any changes in Detention Officer Basic curriculum to the POST Commission at the end of 2023.

#### Mental Health First Aid

- Roy Eckerdt states that the grant funding for a Train the Trainer course is likely to come through.
  - o It is currently in the contract-writing stage.
- The cost is \$26,000 for 1 week of training for 16 people.
- The grant would cover this cost for WLEA instructors as well as individuals from agencies across the state.
- WLEA is looking to incorporate the Public Safety Module of this course into all Basic Trainings in the future.

## Facility Report

- An entirely new facility is currently cost-prohibitive, so WLEA is making improvements to the current facility.
- Classrooms have been updated cosmetically, and have new technology installed.
- 2 large projects currently in the planning phase:
  - o Build a 300-yard range
  - o Upgrade old locks to electronic key cards

#### Communications Basic

- The updated Communications Basic curriculum is available for review in the packet provided to the Board.
- There are several new topics that were not previously taught
  - o Critical vs Non-Critical incident management
  - Physical fitness & nutrition (Wellness)
  - o PT activities such as yoga and walking
  - Mental Health First Aid
- The new schedule has the class on campus for 2 weeks
- Current practicals are not advanced enough, as most students come to basic with about a year of experience working as a dispatcher
  - o The new practicals would have students act in 2 roles: the dispatcher and the officer (or the officer's shadow, providing the communication).
  - Adding the aspect of playing the officer is something new they likely have not done.
- CTAB has approved the updated curriculum.
- WLEA will present the new curriculum to the POST Commission in the January 2023 meeting.
