

# 2025 Peace Officer Basic POST Approved Curriculum



#### **SUMMARY OF CHANGES**

Several factors influenced the changes to the 2025 Peace Officer Basic Curriculum. First, the Job Task Analysis completed this year required us to add a new curriculum and distinguish between tasks officers needed to know how to do versus tasks officers needed to be able to do. Second, we studied the average time on task for all independent online activities, allowing us to allocate curriculum time properly. Third, the new proposed schedule is team-focused to increase opportunities for learners to practice and develop cohesion. While this requires more staff resources, it also allows for more curriculum time devoted to practical application without increasing the length of basic training. Finally, we greatly increased PT sessions at the class and team level.






#### **SUMMARY OF CHANGES**

As has been discussed during previous sessions over the past four years, the transitions we have made in delivery methods are from passive to active methods. These methods have been generalized into five categories for this document: Lecture, Static Learning, Online Independent Learning, and Practical Learning. The Lecture category comprises methods delivered through traditional instructor-centered lectures, regardless of whether the instructor attempts to elicit class participation in some manner or not. The Static Learning category is the physical skills equivalent of lectures.

These delivery methods largely lack contextual elements and focus on learners mimicking a physical skill progression. The Online Independent Learning category comprises the online delivery structure of new content. It does not include delivery methods that require learners to apply or integrate concepts they have learned. The Practical Learning category comprises delivery methods that include contextual elements and require learners to achieve outcomes utilizing novel processes (applications) of their creation. The final category is Administrative and comprises curriculum time utilized to facilitate the logistical functions of training, such as exams, orientations, and graduation.




Before 2020, most delivery methods at WLEA were passive, accounting for 475.5 curriculum hours (78.6%). 240.5 hours were delivered by Lectures and 235 hours by Static Learning Activities. Online Independent Learning Activities accounted for 17.5 hours (2.9%). Practical Learning accounted for 86.5 hours (14.3%). Administrative hours accounted for 25.5 hours (4.2%).

By 2024, we successfully "flipped" the curriculum from passive to active. Passive learning methods dropped by 53%, accounting for 223.5 curriculum hours (36.9%). Lectures decreased by 63.3%,


accounting for 87.5 hours, while Static Learning Activities dropped by 42% to 136 hours. Online Independent Learning Activities, now an extremely active learning activity, increased by 86% to 125.5 hours. Practical Learning increased by 62.5% to 230.5 hours.



The proposed 2025 curriculum seeks to continue increasing Practical Learning. The proposal includes decreasing Lectures by 2.4% to 72 hours, maintaining Static Learning Activities at 136 hours, decreasing Online Independent Learning Activities by 2.3% to 111 hours, and increasing Practical Learning by 9.9% to 294 hours. The proposal, if approved, would result in Lecture accounting for 11.7%, Static Learning Activities accounting for 22.2%, Online

Independent Learning Activities accounting for 18.1%, and Practical Learning accounting for 48.0%.

The proposed changes represent a 240% increase in Practical Learning and a 289% increase in active learning methods from the traditional curriculum.



The Criminal Law Competency is proposed to increase by 1,033% over the traditional curriculum to 34 hours. The Interpersonal Interactions Competency will increase by 300% to 8 hours. The Professional






Skills Competency will increase by 177% to 43 hours. The Operational Skills Competency will increase by 1,375% to 177 hours. And the Investigative Skills Competency will increase by 820% to 23 hours.

#### POTENTIAL DELIVERY METHODOLOGY CHANGES

Some have suggested reverting "online learning" back to lectures. Despite the research and our own results, these individuals believe it is better for students. Given the changes to the curriculum, such a reversion would dramatically impact Practical Learning. There are generally three options hypothetically available: the proposed 2025 curriculum, the traditional curriculum, or the traditional curriculum with the same amount of Practical Learning as the proposed 2025 curriculum.





Students' average scores were 4.7% higher on exams in topics learned through Independent Learning Activities compared to topics learned through lecture. Students averaged 93.5% on topics learned through Independent Learning Activities and 88.7% on topics learned through lecture. Peace Officer Basic students' average scores were 3.8% higher through Independent Learning Activities

(92.3%) than Lecture (88.5%). Detention Officer Basic students' average scores were 5.6% higher through Independent Learning Activities (94.6%) than Lecture (89%).





Eliminating online activities and moving back to the traditional curriculum within the given timeframe would require 17.5 hours more lectures, 99 more hours of Static Learning, and a reduction of Practical Learning by 198.5 hours. Keeping the Static Learning hours at 136 and moving the 99 additional hours to Practical Learning will not work, as the active learning methods currently being utilized are a prerequisite for doing more practical activities within the timeframe. Eliminating the Online Independent Learning Activities while maintaining the amount of Practical Learning proposed in the 2025 curriculum would require a significant increase in curriculum and training hours. Individual Practical Learning Activities that currently utilize the online platform will increase training time on average by a factor of 20 to accommodate the in-person platform, much like Use of Force Practicals, which currently requires 20 training hours to fulfill one curriculum hour per student. The proposed curriculum has 12 hours of individual Practical Learning Activities, requiring an additional 240 training hours.

Adding the proposed 285 Practical Learning Activity hours to the traditional curriculum would result in at least 778 total curriculum hours and at least an additional 240 training hours (1,018), which equates to a 22 ½ week basic training schedule with the current weekly average of 45 hours per week.

It currently costs WLEA \$124 per day per Peace Officer Basic student. The proposed 2025 curriculum would be scheduled over 13 ½ weeks (68 training days). The traditional curriculum was scheduled over 15 weeks (75 training days). The traditional curriculum with practicals must be scheduled over at least 22 ½ weeks (113 training days). The cost of the proposed 2025 curriculum is \$8,432 per student per basic class. In 2024, we trained 93 Peace Officer Basic students for \$784,176. The traditional curriculum would cost an estimated \$864,900, a 10.3% increase. The traditional curriculum with practicals would cost an estimated \$1,303,116, a 66.2% increase.

In addition, agencies currently pay \$3.75 per meal for basic students. The proposed 2025 curriculum would require 190 meals per student per basic, the traditional curriculum would require 210 meals, and the traditional curriculum with practicals would require 316 meals. This equates to \$712.50 for the proposed 2025 curriculum, \$787.50 for the traditional curriculum (10.5% increase), and \$1,185.00 for the traditional curriculum with practicals (66.3% increase). Under the proposed 2025 curriculum, students must remain at the academy for nine additional days. This is due primarily to the increased curriculum requirements established by the Job Task Analysis. The traditional curriculum would require an additional 16 days, and the traditional curriculum with practicals would require an additional 52 days.
